## Tuition Contract 2021-2022

### Tier 1 Tuition - Families fulfill all 3 requirements

1. Families are active members of St. Veronica Parish. Families support the parish with their time, by attending Mass regularly, including "Grade-level" Masses and Sports Masses, with their talent by serving in parish ministries, with their treasure by donating to weekly collections, the Archdiocese Annual Appeal, and any Capital Campaign.
2. Families log at least thirty (30) hours of service by April 30, 2022. These hours must include at least six (6) hours of service for the Parish Festival and participation in their oldest or only child's class assignment or project. Families support all school fundraisers through time, talent, or treasure.
3. Families attend all mandatory school meetings, plus at least two Parent Guild or Men's Club meetings. Each meeting attended is worth 1 service hour.

One Child	\$7,776 - \$648 per month for 12 month (July – June)
Two Children	\$13,968 - \$1,164 per month for 12 months (July – June)
Three or More	\$18,648 - \$1,554 per month for 12 months (July – June)

### Tier 2 Tuition - Families fulfill 2 of the 3 requirements

1. Families are active members of St. Veronica Parish. Families support the parish with their time, by attending Mass regularly, including "Grade-level" Masses and Sports Masses, with their talent by serving in parish ministries, with their treasure by donating to weekly collections, the Archdiocese Annual Appeal, and any Capital Campaign.
2. Families log at least thirty (30) hours of service by April 30, 2022. These hours must include at least six (6) hours of service for the Parish Festival and participation in their oldest or only child's class assignment or project. Families support all school fundraisers through time, talent, or treasure.
3. Families attend all mandatory school meetings, plus at least two Parent Guild or Men's Club meetings. Each meeting attended is worth 1 service hour.

Two Children	\$16,632 - \$1,386 per month for 12 months (July – June)
Three or More	\$24,948 - \$2,079 per month for 12 months (July – June)

### Tier 3 Tuition - Families don't fulfill any requirements

One Child	\$9,240 - \$770 per month for 12 month (July – June)
Two Children	\$18,480 - \$1,540 per month for 12 months (July – June)
Three or More	\$27,720 - \$2,310 per month for 12 months (July – June)

### Additional Tuition Information

- Your fulfillment of your 2021-2022 Tuition Contract will determine your tuition tier for the 2022-2023 school year.
- St. Veronica Catholic School employs SMART, a tuition management system. Families must register with SMART for tuition collection.
  - If payments are not received by the due date (either the 15<sup>th</sup> or 30<sup>th</sup> of each month), a late charge of \$50 will be added to your SMART Tuition account.
  - There is a \$30 charge for any returned checks or failed payments handled by SMART tuition.
- There is a non-refundable Registration Fee of \$325 per student at the time of registration. This fee covers: ACRE, ARK, and STAR testing, SchoolSpeak, Virtus, CTN, Art in Action, Extended Care Registration, instructional materials, class party fee, student insurance, and administrative fees.
- I understand that I am registering my child/ren for the entire 2021-2022 school year, and that a spot at St. Veronica Catholic School is therefore being held for my child/ren. Tuition is collected over a twelve (12) month period (July 1, 2021 - June 30, 2022) with the exception of families that have a child in 8<sup>th</sup> grade. **Tuition for all 8<sup>th</sup> grade students is collected over a ten (10) month period (July 1, 2021 - April 15, 2022). All 8<sup>th</sup> grade tuition fees must be current before graduation.**
- At the end of each trimester the principal will consider the possibility of dropping the student(s) from enrollment for the following trimester or school year if they meet the following criteria:
  - Are delinquent in their tuition account.
  - Have made no effort to discuss and correct the problem with the principal.

In the event that a family is removed from the school at the end of a trimester for non-payment of tuition, past-due tuition through the end of that trimester will remain payable and tuition already paid is not refundable.

Parents will be held responsible for reasonable attorney's fees and collection costs necessary for the collection of any amount not paid when due.

- Families leaving St. Veronica Catholic School during the 2021-22 school year are responsible for tuition for the entire month in which they leave.
- By signing this agreement, parents/guardians expressly authorize the school to release information regarding the tuition account along with other necessary records which are requested by any public and/or private school, local credit bureau, collection agency, or any school official, employee or agent who has a legitimate educational or legal interest in the information.
- Registration is considered complete when tuition for the current school year is paid in full and the following school year's registration fee is paid. Families with delinquent tuition accounts will not be allowed to re-enroll for the following year.
