Tier 1 Tuition Rate – Families fulfill all 3 requirements

Tuition Requirements:

1. All families are to be registered members of St. Veronica Parish. The School is integrated into the mission and ministry of the Parish. The School families (parent/guardian along with their St. Veronica student), are expected not only to attend Mass regularly on Saturdays (Vigil) or Sundays, including "Grade-level" Masses and "Sports" Masses, but also to participate in the stewardship through time, talent, and treasure for the parish. Families are required to support the parish ministries through weekly donations by using the prescribed donation envelopes placed in the collection basket at least 26 times per calendar year (January 1 - December 31). Please note: more than one envelope placed in the mass collection basket will only be counted as one mass attendance. Envelopes deposited by proxy are not permitted. Families are expected to support the Archdiocesan Annual Appeal and any Capital Campaigns of the parish.

2. Families must complete at least thirty (30) hours of service by April 30, 2021. These hours must include at least six (6) hours of service at the Parish Festival. Additionally, families are expected to participate in their oldest or only child's current academic school year class assignment.

The assignments are as follows:

Kindergarten – Grade Three Bingo Supervisors/Workers (minimum of 3 shifts)

Grade Four Snack Shack (minimum of 3 shifts)

Grade Five Santa's Breakfast
Grade Six Luck of the Irish Dinner

Grade Seven Crab Feed

3. All families are required to attend at least two Men's Club or two School Guild meetings, plus any mandatory school meetings. Each meeting attended is worth 1 service hour.

Any family that steps up to be a Festival Booth Chair is exempt from their Class Assignment.

Additional Tuition Information

- St. Veronica Catholic School employs SMART, a tuition management system. Families must register with SMART for tuition collection. All families will be on the SMART tuition management system.
 - If payments are not received by the due date (either the 15th or 30th of each month), a late charge of \$50 will be added to your SMART Tuition account.
 - o There is a \$30 charge for any returned checks handled by SMART tuition.
- There is a refundable Registration Fee of \$300 per student at the time of registration.
- Each family must pay the annual additional school fees of \$210. This will be billed to your July 2020 Smart Tuition Invoice. The fees include: School Guild Dues - \$75, Men's Club Dues - \$75, Extended Care Registration - \$35, and Bingo Dessert Fee - \$25.
- I understand that I am registering my child/ren for the entire 2020-21 school year, and that a spot at St. Veronica School is therefore being held for my child/ren. The tuition is collected over a twelve (12) month period (July 1, 2020 through June 30, 2021) with the exception of families that have a child in 8th grade. The tuition rate for all 8th grade students is collected over a ten (10) month period (July 1, 2020 through April 15, 2021). All 8th grade tuition fees must be current before graduation.
- At the end of each trimester the principal in consultation with the pastor will consider the possibility of dropping the student(s) from enrollment for the following trimester or school year if they meet the following criteria:
 - Are delinquent in their tuition account.
 - Have made no effort to discuss and correct the problem with the principal or pastor.

In the event that a family is removed from the school at the end of a trimester for non-payment of tuition, past-due tuition through the end of that trimester will remain payable and tuition already paid is not refundable.

Parents will be held responsible for reasonable attorney's fees and collection costs necessary for the collection of any amount not paid when due.

• Families leaving St. Veronica Catholic School during the 2020-21 school year are responsible for tuition for the entire month in which they leave.

- By signing this agreement, parents/guardians expressly authorize the school to release information regarding the
 tuition account along with other necessary records which are requested by any public and/or private school, local
 credit bureau, collection agency, or any school official, employee or agent who has a legitimate educational or
 legal interest in the information.
- Registration is considered complete and valid when tuition for the current school year is paid in full and the
 following school year's registration fee is paid. Families with delinquent accounts will not be allowed to re-enroll for
 the following year.
